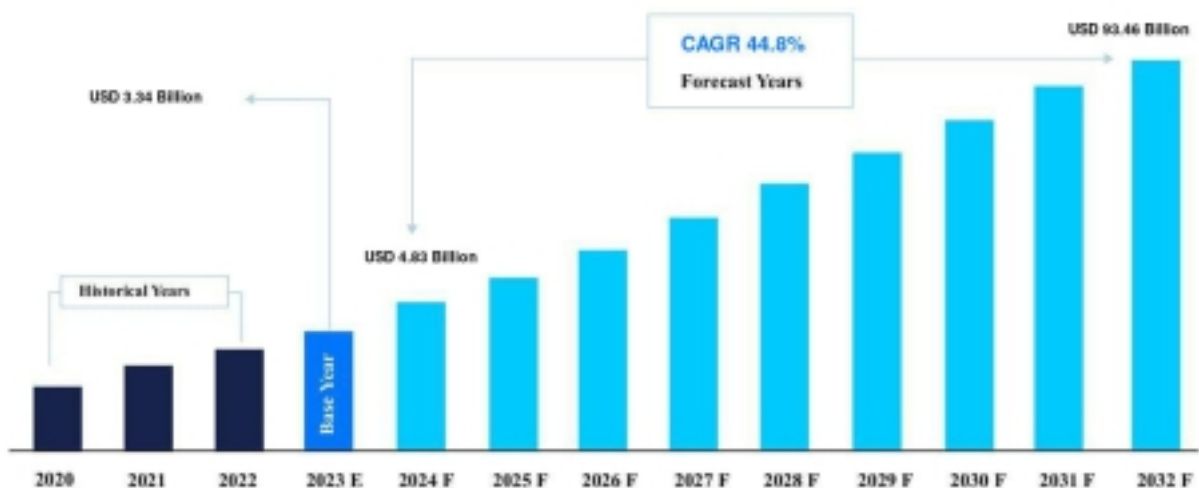
## Cryptocurrency Globalization

Keeping ourselves up-to-date with the dynamic regulatory landscape regarding cryptocurrencies of various jurisdictions enables us to examine the presented platforms in accordance with legal criteria for anti-money laundering (AML), know your customer (KYC) protocols, and prevention of financing terrorism.

## Privacy and Security Measures

Our policy to safeguard cryptocasinos.online users' data and transactions is based on strict privacy norms and digital security practices. These include:

Curacao issues a single licence that enables your site to offer the full gamut of gambling products, and the application process is much easier (and the cost much lower) than for European licences.

#### **MALTA:**

The Malta Gaming Authority (MGA) is the strictest of the jurisdictions, and one of the earliest to create legislation specific to cryptocurrency gambling. The MGA provides a good environment for security, fairness and corporate responsibility.

#### **ISLE OF MAN:**

Licences are granted by the Gambling Supervision Commission and bear the seal of approval, with a clause giving legal sanction to cryptocurrency use, as per anti-money laundering and other KYC standards and security specifics.

## **2. Regulatory Trends**

#### **CRYPTO ADOPTION:**

Some jurisdictions are adapting their domestic laws to incorporate cryptocurrencies expressly – some as cash equivalents – others as a new species of assets (ie, digital property).

#### **KYC AND AML STANDARDS:**

Even if the currency is deemed a commodity, anti-money laundering (AML) and know-your-customer (KYC) standards are increasingly the norm for online casinos trying to protect themselves from fraud and illicit activities.

## **3. Compliance Statistics**
